Subject:	Clarifying Notice: Prior Authorization Requirement for TCM Services

Provider Notification

This notice is to clarify upcoming changes related to Targeted Case Management (TCM) services.

Effective **July 1, 2025**, **prior authorization will be required** for all individuals receiving TCM services. This requirement applies to any claim representing a **new month of service** (whether on a rolling or calendar month) **beginning on or after July 1, 2025**.

Please note that prior authorization requirements will resume for all other services on June 25, 2025. Please see our previously published network notice here:


