Partial Hospitalization Program (PHP) Covered Services

Aetna Better Health of Kentucky would like to remind providers about the regulatory requirements for coverage and reimbursement of PHP (H0035) services.

- PHP is an intensive treatment program for an adult or minor who is experiencing significant impairment to daily functioning due to a mental health or substance use disorder.
- PHP is a short-term program with an average of four (4) to six (6) weeks.
- PHP services must be provided at least four (4) hours per day, focus on (1) primary presenting problem, and be **provided face-to-face**.
- PHP programming is inclusive of **individual therapy, group therapy, family therapy and medication management**.
 - Medication Management services provided to address the recipient's mental health or substance use disorder are included in the PHP service and are not separately billable. Medication management is inclusive of the following activities performed within an evaluation and management service.
 - Management, involving prescribing and reviewing medications for their side effects.
 - Monitoring, involving observing and encouraging patients to take their medications as prescribed.
 - Administering oral or injectable medication.
 - Training and educating patients and families on how to follow their medication regime and the importance of doing so.

Partial Hospitalization Program (PHP) Required Staffing

<u>A PHP operated by a Behavioral Health Service Organization (BHSO) or Community Mental Health</u> <u>Center (CMHC) must include the following personnel.</u>

• An advanced practice registered nurse, a physician assistant, or a physician <u>available on-site</u> <u>during PHP program hours.</u>

In addition, to provide PHP, the provider group must have:

• Access to a board-certified or board-eligible psychiatrist for consultation.

What does "access to" mean? "Access to" means that the provider group must have a contract with a psychiatrist for consultation.
